#### Constitution, Rules and By-Laws of the Society:

1. The Society shall be called the "Dalmatinkso Kulturno Društvo Incorporated"

# **REGISTERED OFFICE:**

2. The Registered Office shall be at such place as the Management Committee shall from time to time determine. **OBJECTS:** 

- 3. The objects of the Society shall include those to:
- a) To extend, foster and cultivate the cultures of all of the people from the states that made up the former Yugoslavia
- b) To promote and foster friendship unity and co-operation between the peoples of origin from the states that made up the former Yugoslavia and those of other origins and particularly the people of New Zealand.
- c) To organise, establish, and if thought fit, endow or subsidise bands, orchestras, choirs and folklore groups.
- d) To organise and/or promote social functions, intellectual, sporting, educational and cultural activities, including the teaching of languages of the states that made up the former Yugoslavia and other languages.
- e) To help poor and needy members and to visit the same in hospitals and other institutions.
- f) To promote entertainments for the benefit of members of the Society.
- g) To hold regular meetings at which matters of interest to the Society will be discussed.
- h) When considered necessary to publish or assist in the publication of papers and/or periodicals dealing with matters of common interest to members of the Society and generally to issue publications to further the objects of the Society.
- i) To affiliate with organisations whose objects are similar or considered likely to be conducive to the attainment of the Society's objects, or any of them.
- j) To raise funds by means of subscriptions, donations, bequests, levies, loans (whether secured or unsecured) and debentures.
- k) To accept any sum of money or property bequeathed or donated to the Society upon the terms of such bequest or donations.
- To purchase, take on, lease, sub-lease, rent, hire or otherwise acquire any land and/or building(s) and to erect building(s) for the purposes of the Society and to sell, lease, sub-lease, rent, hire or otherwise dispose of upon any terms the whole of or any part of any such property and generally manage the same.
- m) To organise, establish and if thought fit, endow or subsidise branches of the Society in any part or parts of New Zealand.
- n) To organise, establish and if thought fit, endow or subsidise any activities within the framework of, or conducive to, the furtherance of the objects of the Society.
- o) To do all things considered to be conducive to the attainment of these objects or any of them or to be otherwise for the benefit of its members or any of them.

#### Provided always that:

- I. The Society shall seek its objects free of sectarian, religious or political alignments.
- II. No object, except where its context expressly provides shall in any way be limited or restricted by reference to, or inference from, the terms of any other object.
- III. The Society shall have full power to exercise any of its objects independently of any other.
